tuition assistance to families who wish to send their children to Catholic schools. Thanks to the hard work of our Board of Directors, support from Archbishop Sample, and the wonderful generosity of our growing network of donors, we are making great strides towards fulfilling that mission.

The advantages of a Catholic school education are clear: a safe and nurturing environment, high school and college preparedness, increased accountability and empathy toward others, conflict resolution skills and generally less disruptive behavior - to name a few. These advantages are a direct result of the freedom to embrace and proclaim Christ's message. We believe that they are worth the sacrifice.

Unfortunately, it's becoming more difficult to afford Catholic school with each passing year and through each generation. Much of this change can be attributed to the cost of labor, the single biggest expense of running a school. In years past, most of the faculty and staff in the Catholic school system were priests and sisters living in community for whom teaching was part of their religious vocation. Their labor was a "living endowment," benefiting the schools and parishes they worked for. Today, lay people fill these positions.

In my nearly 20 years in Catholic school development, I have held firm to one contention: there is no lack of families who wish to attend Catholic schools, there is a lack of families who can afford it.

I hope that you enjoy this publication, that you see faces you know among the photos or names you recognize among our donor list, and that you, too, are moved to help families to keep their children right where they want them to be, through a gift to CSEF. Together, we can offer the promise of a Catholic school education to families making great sacrifices to provide that gift for their children.

Dear Friends:

Like a lot of you, I owe a lot to my parents for their commitment to sending me to Catholic schools. Eight years at Madeleine and four

at Jesuit gave me an incredibly solid spiritual and educational foundation for life. My wife Julie (Vernier-All Saints/Holy Child) and I were fortunate to be able to send our three daughters to Catholic schools. We firmly believe that this gave each of them the same solid foundation we received. However, as we all know, Catholic school education is a financial sacrifice for all families. For some, the financial sacrifice is more than they can afford. That is why a little over 10 years ago a small group of believers in Catholic school education developed a plan for an independent foundation devoted to providing financial assistance for families to send their children to Catholic schools.

In 2017, with the strong support of Archbishop Sample the Catholic Schools Endowment Foundation of Oregon was formed with one single purpose: To provide need-based financial aid to families to send their children to the Catholic school of their choice in the Western Oregon Archdiocese. After three years we are off to a good start. We recently distributed nearly \$500,000 of financial aid to families all over the diocese to help with the rising cost of tuition so that families can get their children started in Catholic schools as young as kindergarten. However, we have a long way to go. To fulfill the existing need for financial aid in the diocese just for elementary schools, we need to distribute in excess of \$4.5 million per school year. This will be done using investment income from the CSEF Endowment Fund and from the CSEF Annual Financial Aid Fund. It is a big task but we know it can be done. More importantly, we know that it needs to be done.

The word investment gets used a lot in philanthropy but almost all research shows that a high quality, faith-based education produces young adults who are caring, productive and solid members of their community. I hope you will help us in this effort.

# Our Story

Like most good ideas, the Catholic Schools Endowment Foundation didn't start when it "started." It took years of work before it came into being, the brainchild of inaugural Board Chairman David Brands and his friend Bob Keerins. Themselves the product of Catholic schools, both David and Bob have been passionate advocates for Catholic school education for many years. They recognized its importance in their own lives and saw it as an incredible gift, which they felt should be shared with all families who wanted it for their children.

### An option for all families

They recognized that some parishes and communities had the resources to help families struggling to meet their tuition obligations, while others did not. They believed all families deserved the blessings of Catholic school education and the seeds of faith, regardless of their financial situation.

The Archbishop, a passionate advocate for Catholic schools, embraced the idea immediately. He gifted nearly \$7 million from restricted funds for tuition assistance with the charge to build it into an endowment which will make Catholic schools accessible to all families.

Under the leadership of a wonderful Board of Directors, CSEF has added nearly \$2 million in endowment gifts and pass-through grants. Our goal is to leverage the generosity of everyone in Western Oregon to support **all** families who demonstrate need. CSEF is in the unique position to match resources with families. We liaise with principals and pastors from all of the diocesan elementary schools to evaluate who has the greatest remaining need after each parish has distributed their own tuition assistance resources.

#### The need is real

This year, in elementary schools alone, the assessed need for families in Western Oregon was \$4.5 million. Increasing tuition obligations will continue to weigh heavily on even more families each year. A coordinated effort that employs a growing endowment and pass-through grants for immediate need is the solution. For example, \$50 million will provide \$2.25 million a year in perpetuity to add to the resources each school shares with their own families. We are approaching \$10M and are only just beginning to introduce the Foundation publicly. Subsequent gifts and investment earnings will ensure continued growth and ever more resources to share in perpetuity.

### **CSEF** helps fill the gap

Right now there are over 1,400 empty seats in our diocesan elementary schools. Filling those seats will not only benefit students and families, but also provide additional tuition revenue for more robust operating budgets for schools to pay their teachers commensurate wages to public school peers and to continue building quality into academic programs. And the student bodies of our schools would more accurately reflect the communities they serve.

We are blessed and grateful for the incredible examples and hard work of Archbishop Sample, David, Bob, and so many others to get this foundation on solid ground. Please join us in supporting all of the Catholic school families in Western Oregon making great sacrifices to remain in, or to enroll in their neighborhood Catholic school. Please join our effort to solve the problem of accessibility to Catholic school education and to return our schools to full enrollment in Western Oregon.





At 85, retired physician Don Romanaggi is busy as ever. When he's not spending time with his children and grandchildren, Don is working to promote excellence in Catholic school education throughout the archdiocese of Portland and beyond. As a founding member of the Board of Directors, Don helped lay the groundwork for the Catholic Schools Endowment Foundation of Oregon and his generosity is reaching hundreds of families across the state.

Don's parents came from southern Italy -- "the Achilles heel of the boot," Don says, with an anatomical analogy befitting someone with a 30-year career in medicine. His mother's weekly attendance at mass not only nourished her faith but also nurtured the family's connection to their native land, especially when the novenas were said in Italian once a month. For Don, supporting Catholic school education is a way of honoring this heritage.

As a child, Don displayed a talent for math and chemistry. In fact, he'd always hoped to study science at St. Philip Neri in Southeast Portland, but the tuition was out of reach for his family. Ironically, the school has since closed due to low enrollment. "If there aren't enough students to attend, more schools will close like St. Philip's did," Don pointed out. That's part of the reason why he is dedicated to giving other youngsters the chance he never had.

After graduating from the University of Portland in 1956 and going on to earn his medical degree at Loyola University in Chicago, Don returned to Portland to set up a private practice as an allergist and immunologist. Meanwhile, he got involved with alumni life at his alma mater, the first step on a journey which would become a 50-year legacy of philanthropy. He has been a member of the Board of Regents at the University of Portland since 1991.

Don has been a pillar of the Catholic school community in Oregon for decades. Scholarships set up by, and in many cases named for, Don and his late wife Agnes Romanaggi have helped scores of young students receive an excellent education. His dedicated service is helping build CSEF into a new model for sustaining Catholic school education well into the future. Thank you, Don!
